# 2023 Annual Membership Meeting - Highlights

Our annual Membership Meeting in October focused on Traffic & Safety, one of our members' top two priorities consistently in recent years. This meeting was open to non-members given the important topics. The guest panel included County Supervisor Rich Desmond, representatives from local elected government, Sacramento County Sheriff's Deputies, and the California Highway Patrol.

Attendees were asked to submit their 'burning questions' and we had quite a few. The top issues expressed by those in attendance included:

- ISSUE: Concern about reckless/dangerous driving, including speeding, running stop signs, not paying attention and nearly hitting pedestrians or other cars.
  - With CHP having primary accountability on this along with very limited resources, their staff is concentrated on high impact accidents and risks and can't patrol our streets regularly. Always report incidents appropriately.

\* ISSUE: What is required by the County to get speed bumps and stop signs in problem areas.

- An explanation of the Neighborhood Traffic Management Program was reviewed in detail.
- \* ISSUE: What are regulations for golf carts (and e-bikes), including vehicle, traffic and driver requirements.
  - ALL vehicles driven on public roads must be registered with the DMV and drivers must be licensed. Street-legal golf carts must be registered, have headlights and taillights, brake lights, reflectors, mirrors, turn signals, a windshield, a horn, and seatbelts.
  - All owners of golf carts should research regulations (CVC-345 and CHP.CA.GOV) and follow them. Many reported issues in our area involve children driving golf carts and concerned underage drivers.
- ISSUE: What should we do when we observe dangerous drivers/vehicles, including underage drivers, operation while impaired or distracted, etc.
  - If an existing emergency, call 911. But if a non-imminent issue, ie observed and now gone, then report issues/concerns to the CHP via email to 250POP@chp.ca.gov. This email is monitored daily and issues are aggregated to help prioritize patrol priorities of existing patrol staff. CHP responds to all reports as time/priorities align.
- ISSUE: When should we call 311?
  - Call 311 or fill out online form to report nuisances, code violations, abandoned vehicles, etc.


